#### **PRIMARY PURPOSE:**

The Sustainability Coordinator will advance Rhode Island College's efforts to become a sustainability leader in higher education by working with senior administrators, students, faculty, staff, and community partners to provide the knowledge, skills, and motivation that will integrate sustainability values and practices into the college's strategic planning processes. The coordinator will serve as the campus spokesperson on sustainability issues with internal and external constituencies and organize and oversee the implementation and management of a comprehensive co-curricular program to promote awareness of environmental sustainability to establish a campus culture that fosters responsible stewardship of resources on campus and in the community. The coordinator will explore workforce development needs and opportunities related to sustainability in the community and lead the development of credit and noncredit courses and programs to provide required training, skills, and knowledge.

## **DESCRIPTION OF DUTIES AND RESPONSIBILITIES:**

#### **Essential Job Functions:**

- Create and administer robust campus co-curricular sustainability programming that advances knowledge of, and participation in, campus and community sustainability initiatives. Will be responsible for the development and implementation of a minimum of two new programs each term.
- Serve as coordinator of the Rhode Island College Green Team to promote sustainable practices by working directly with operational units, academic departments, student organizations, senior administrators, and community organizations to coordinate and/or enhance involvement in the college's sustainability initiatives. Meetings will be held on a monthly basis from September to April; and the coordinator will prepare and provide mid-year and final reports to the Green Team on membership, business, and accomplishments.
- Work with community and campus partners to identify workforce development needs related to sustainability and lead the development of credit and non-credit courses and programs to address workforce needs. Will be responsible for the development and implementation of a minimum of one new course or training program each term.
- Work with community partners and Career Development to identify student internship opportunities related to sustainability. Will be responsible for the identification of a minimum of two new community student internship opportunities each term.

- Identify grant-funding opportunities and prepare and submit proposal applications for external funding; administer any awarded funds. Will be responsible for a minimum of one new grant proposal submission each term.
- Maintain and update content on the PSCE sustainability Web page; update content in a timely
  manner; incorporate calendar and resource listings and other relevant information and links as
  needed.
- Serve as the campus spokesperson and representative, in consultation with the Office of College Communications and Marketing, on sustainability issues with internal and external constituencies. Use social media to advance knowledge of the college's sustainability initiatives and programs.
- Oversee the campus beekeeping program and Bee Education Center facility and programs.
- Supervise student employees and interns and serve as advisor to the student Environmental Club.
- Increase membership in, and programming sponsored by, the Environmental Club.

#### Education and Campus Outreach:

- Work with academic units and faculty, the Admissions Office and new student programs to make prospective and new students aware of the College's sustainability curriculum, programs, opportunities, and efforts.
- Assist students and faculty with sustainability projects.
- Work with various community sectors and partners to identify and develop workforce training and educational programs related to sustainability.
- Enhance the public image of RIC sustainability practices with effective Web information, traditional and social media, print materials, and other informational materials for campus and external audiences.
- Make presentations to the campus community to promote stewardship and a commitment to sustainable goals.
- Research and maintain working knowledge of best practices at peer institutions with regard to sustainability. Collect and report data and performance metrics at the end of the fall term on campus sustainability initiatives, progress, and future plans.

#### Occasional Job Functions:

Perform other duties and responsibilities as assigned by the Associate Vice President for Professional Studies and Continuing Education.
